Advice Letter No. 523

TO THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Del Oro Water Company, Inc. (DOWC) hereby transmits Advice Letter No. 523 for filing on behalf of all DOWC Districts (DISTRICTS) requesting reimbursement of the uncollected revenue in the amount of \$782,190.17 for its Statewide General Metered Rate Service from January 1, 2020 through August 6, 2020, the time period between which the Interim Rate Increase and the Statewide General Rate Case Increase became effective.

With the approval of the Statewide General Rate Case the current \$10.54 Lost Revenue Surcharge has been eliminated. The Lost Revenue Balancing Account (LRBADS) will remain in place until all litigation is finalized and disposition of amounts recorded in the LRBADS is determined by a regulatory proceeding, as authorized by the Commission.

In accordance with California Public Utilities Commission Resolution No. W-5229 [Exhibit A], the following changes in its tariff schedules are attached hereto:

<u>Purpose</u>

The DISTRICTS of the Utility hereby request a one-time surcharge to recover \$782,190.17, the amount of uncollected revenues for Metered customers, in an amount as presented in **[Exhibit B]**, from January 1, 2020 through August 6, 2020, the period of time between the Interim and Statewide General Rate Increases.

Effective with Commission approval of the GRC on August 6, 2020, DOWC was granted a Statewide General Rate Increase producing additional annual revenues of \$1,392,932 for test year 2020. The difference between that granted in the Interim Rate Increase and the General Rate Increase resulted in a shortfall of \$782,190.17.

The CPUC staff will make a thorough investigation of the utility's request. Following the investigation, the CPUC may grant the utility's request in whole or in part, or may deny it. Customers who would like to call the CPUC's attention to any problems concerning their water service, or who would like to provide any other information or comments regarding this requested change should do so by writing to the CPUC.

The Customer Notice will encourage customers to contact Del Oro at (530) 717-2500 or (877) 335-6764 with any questions regarding this DOWC Interim Rate Increase. In addition, there are two ways to respond to this notice. You may send a protest to the CPUC's Water Division, and if you do, you must send a copy of the protest to DOWC, or you can send a response to the CPUC and mention "DOWC Uncollected Revenues Shortfall".

File A Protest

A protest is a document stating that you object to the utility receiving all or some part of its request. If you wish to file a protest, you must state the facts constituting the grounds for the protest, how the advice letter affects you, and the reasons why you believe the whole advice letter, or part of it, is not justified.

If the protest requests an evidentiary hearing (an evidentiary hearing is a legal proceeding held before an administrative law judge at the Commission to obtain evidence), your protest must state the facts you would present at the evidentiary hearing to support your request for a complete or a partial denial of the advice letter. The filing of a protest does not ensure that an evidentiary hearing will be held. The decision whether or not to hold an evidentiary hearing will be based on the content of the protest.

File a Response:

A response is a document that does not object to the request sought in the application, but nevertheless, presents information you believe would be useful to the Commission in acting on the application. Comments should mention that they pertain to the "DOWC Uncollected Revenues Shortfall".

AB. Paradise Pines, Magalia, Lime Saddle and Buzztail (DISTRICTS) Lost Revenue Balancing Account (LRBADS)

Del Oro Water Company, Inc. (DOWC) Lost Revenue Balancing Account (LRBADS):

 PURPOSE: The LRBADS is to track the 1) permitted amount of \$800,000 lost revenues associated with the November 2018 CAMP Fire, 2) track the imposed surcharge of \$10.54 per customer per month across all of its districts for a period of 12 months as authorized by the Commission in Resolution W-5193, and 3) track any additional surcharge revenues as allowed per advice Letter 521, filed April 3, (C) 2020, to extend the surcharge by the earlier of three months or when the Statewide Stabilization General Rate Case is approved by the CPUC. An additional \$166,873.67 of lost revenues were collected, totaling the lost revenues to \$966,873.67. The surcharge was eliminated by approval of Resolution W-5229, August 6, 2020.

(C)

2. APPLICABILITY: The LRBADS applies to all of DOWC's districts.

DOWC shall maintain the LRBADS by making entries at the end of each month as follows:

- a. A debit entry from the total collected from each of the DISTRICTS, shall be made to the LRBADS at the end of each month to record the Paradise Pines, Magalia, Lime-Saddle and Buzztail lost revenue for the period of 12 months.
- b. A credit entry shall be made to the LRBADS at the end of each month to record the recovered amount in the LRBADS. The revenue collected from all other districts shall be allocated to the four DISTRICTS based on each DISTRICT'S percentage of the revenue loss at the end of each month. For example; as of April, 2019, the percentages were as follows: 78.4 % for Paradise Pines, 9.8% for Lime Saddle, 10.3% for Magalia, and 1.5% for Buzztail.
- c. A credit from any proceeds specifically for lost revenue from insurance companies, any governmental source, or litigation which may provide revenue for same, to be netted with lost revenues when DOWC amortizes them.
- d. Interest shall accrue to the LRBADS on a monthly basis by applying a rate equal to one-twelfth of the 3-month non-financial Commercial Paper Rate, as reported in the Federal Reserve Statistical Release, to the average of the beginning-of-month and the end-of-month balances.
- 3. EFFECTIVE DATE: The LRBADS shall go into effect on June 8, 2019, five days after the date of filing.
- 4. DISPOSITION: Disposition of amounts recorded in the LRBADS will be determined in a regulatory proceeding, as authorized by the Commission. DOWC will terminate this balancing account when all implementation costs have been incurred and recorded.
