These tariffs are submitted pursuant to Ordering Paragraph No. 1 of Resolution No. W-4540 dated June 16, 2005, and as modified by Resolution No. W-4658. The resolution authorizes Class B and C water and sewer utilities to file by Tier 1 advice letter for an Interim General Rate Case rate increase based on the Consumer Price Index or cash flow, with the Final General Rate Case increase subject to refund back to the date of approval of the increase.

The increased cost is to be passed on to the utility's customers in their Quantity as well as Service Charge Rates. In accordance with W-4540, DOWC is authorized to file the attached rate schedules and to concurrently withdraw and cancel its present schedules for such service.

DOWC requests permission to increase the present monthly Quantity and Service Charge Rates by 3.54%, for the year 2023. 2022 Earnings Test work papers justifying this increase have been provided to the CPUC Water Branch Staff as [Exhibit A].

<u>Requested Effective Date</u>

As this is a Tier 1 filing, DOWC requests that it become effective on March 9, 2023.
