This filing will not cause withdrawal of service, nor conflict with any other schedule or rule.

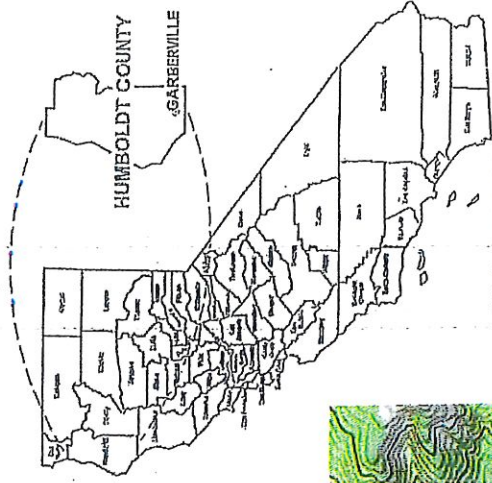
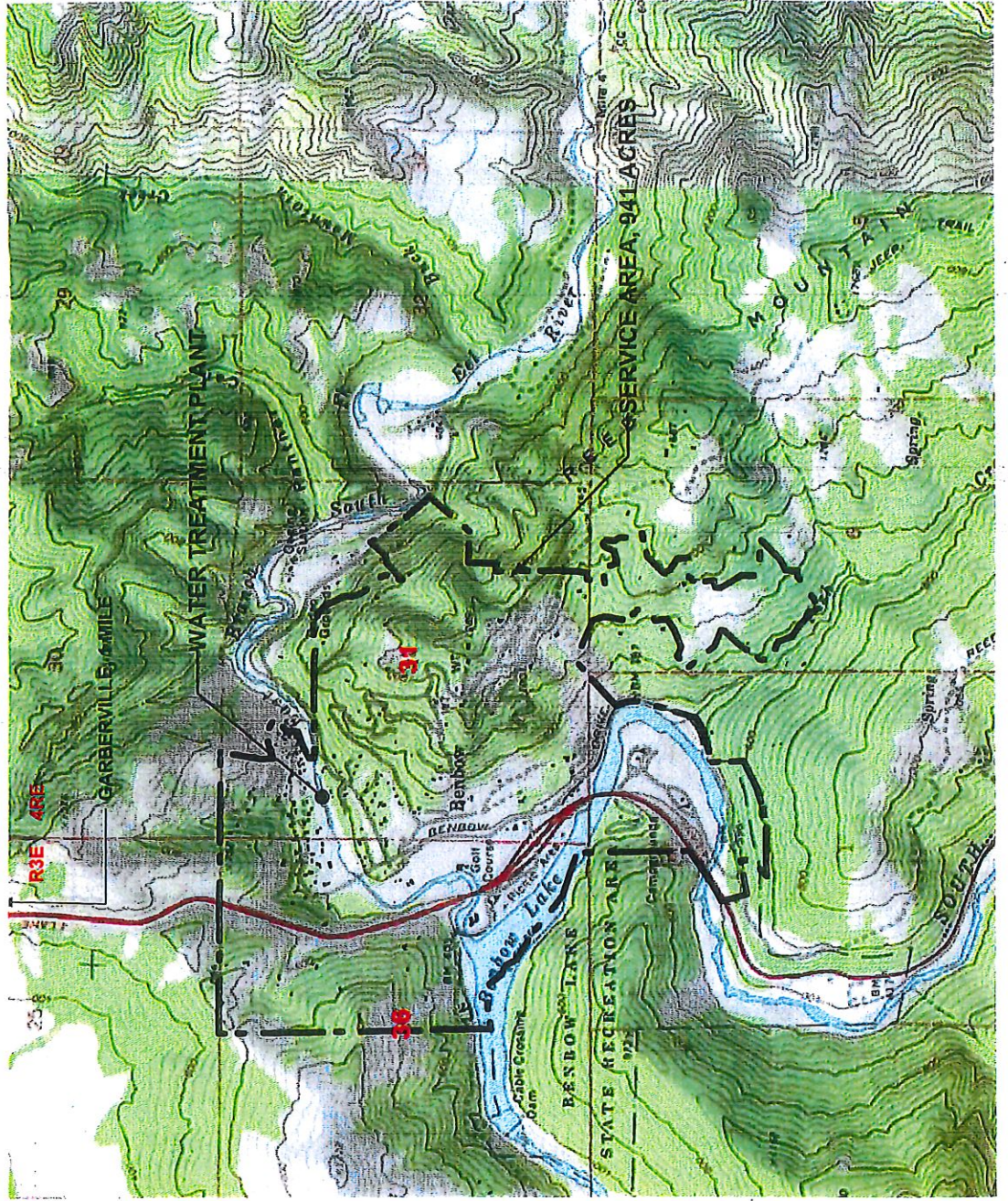

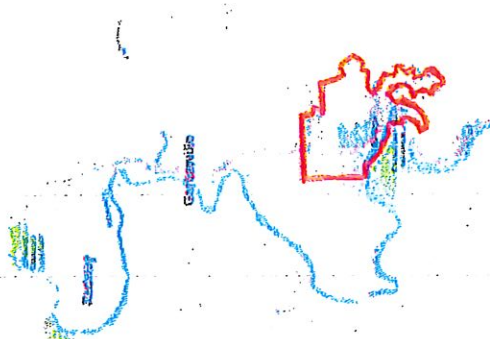

# HUMBOLDT COUNTY DEL ORO WATER COMPANY BENBOW DISTRICT SERVICE AREA

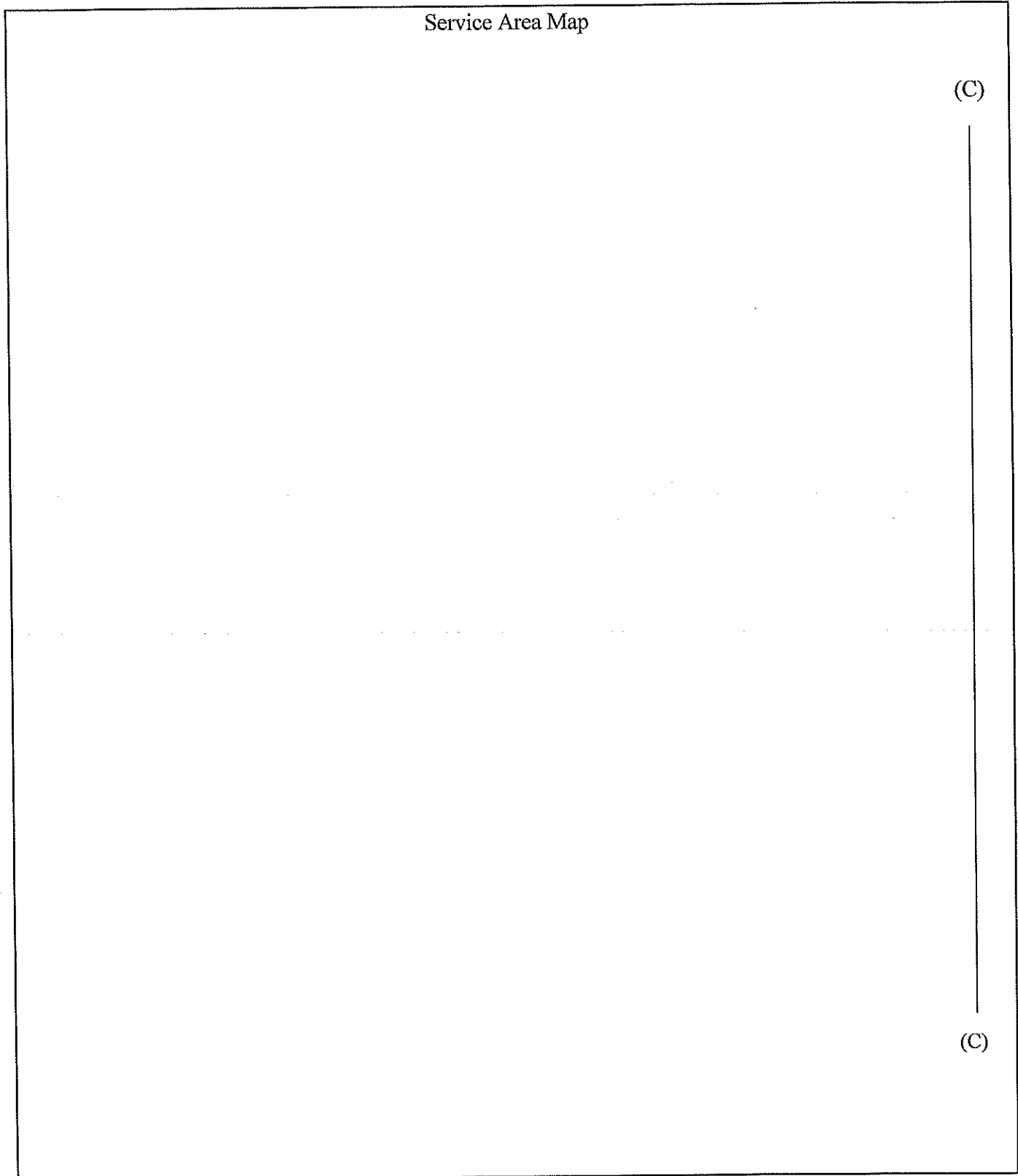
UNINCORPORATED AREA OF HUMBOLDT COUNTY, CALIFORNIA
