

UNSAFE WATER ALERT

**Del Oro Water, River Island Territory 1
South of Tule River is using Non-Potable water due to main line damage**

DO NOT DRINK YOUR WATER
Failure to follow this advisory could result in illness.

This notice only applies to customers South of the Tule River in River Island Territory #1 as shown on streets in **RED of the included map (see reverse). This does not apply to customers in River Island Territory #2 that are served by a Point of Use device.**

In an effort to provide a source of water for sanitary needs (toilet flushing) Del Oro Water is using our Non-Potable (unpermitted irrigation wells) as a temporary source for customers in the Del Oro Water River Island District Territory 1 South of the Tule River, due to the ongoing flooding in the district and main line break. The State Water Resources Control Board, Tulare County Health Department, and Del Oro Water River Island District Territory 1 Water System are advising residents of Springville, CA's River Island District, Territory 1 Water System in areas SOUTH of the Tule River, shown in **RED** on the included map to **NOT USE THE TAP WATER FOR DRINKING AND COOKING UNTIL FURTHER NOTICE.**

What should I do?

- **DO NOT DRINK YOUR TAP WATER---USE ONLY BOTTLED WATER.** Bottled water should be used for all drinking (including baby formula and juice), brushing teeth, washing hands, bathing, washing dishes, making ice and food preparation **until further notice.**
- **DO NOT TRY AND TREAT THE WATER YOURSELF.** Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water safe.

Del Oro Water is unable to advise customers to use this water for bathing or handwashing at this time. We will be performing water testing in the next 48 hours to determine if this source of water is acceptable for these uses. An additional notice will be provided with an update if test results demonstrate that this water source is acceptable for these additional sanitary uses.
