

Del Oro Water Company - Paradise Pines District

2026 Emergency Improvement Plan

IN ACCORDANCE WITH THE STANDARD PRACTICE U-36-W OF THE CA PUBLIC UTILITIES COMMISSION

Please be advised that Del Oro Water is undertaking two (2) emergency projects scheduled to begin this spring. Below is a summary of emergency projects and our best estimate of the costs to complete these tasks along with the total potential impact on rates.

In summary, Del Oro Water Company will immediately undertake:

The first project is scheduled to begin March 30th and is estimated to be completed by April 20th. This project will replace 650 lineal feet of main line on Adrian Court. The estimated cost is \$178,221.

The second project is due to a catastrophic failure during a hillside erosion after the CAMP Fire. This emergency main line replacement project is for a line that brought water from Paradise Irrigation District to the Paradise Pines District overland parallel to the Skyway. The main line will be relocated along the Skyway in the margin of the road. There will be traffic controls in place to insure safety for all. The estimated cost of the project is \$530,779. Construction has been temporarily postponed until final approval from the County. Customers will be notified when the project has been approved and is scheduled to begin.

The total estimated cost for both projects is \$709,000.

The rate impact is approximately \$2.95 per month for the average customer using 1,000 Cubic Feet of water.
